

TERMS AND CONDITIONS

These are the Terms and Conditions ("**Terms**") of SalesPartner BV ("SalesPartner," "we," "us" or "our"), a company having its address at Anna Paulownastraat 27, Den Haag. By accessing or using (mobile) applications, websites or any other SalesPartner service (together, the "**Service**") made available by SalesPartner, however accessed, you agree to be bound by these Terms. The Service is owned or controlled by SalesPartner. These Terms affect your legal rights and obligations. If you do not agree to be bound by all of these Terms, do not access or use the Service.

Registration and account security

1. You must be at least 13 years old to use the Service.
2. You are responsible for any activity that occurs through your account and you agree you will not sell, transfer, license or assign your account, username, or any account rights. With the exception of people or businesses that are expressly authorized to create accounts on behalf of their employees or clients, SalesPartner prohibits the creation of and you agree that you will not create an account for anyone other than yourself.
3. You represent that all information you provide or provided to SalesPartner upon registration and at all other times will be true, accurate, current and complete and you agree to update your information as necessary to maintain its truth and accuracy.
4. You agree that you will not solicit, collect or use the login credentials of other SalesPartner users.
5. You must not attempt to restrict another user from using or enjoying the Service and you must not encourage or facilitate violations of these Terms or any other SalesPartner terms.
6. You are responsible for keeping your password secret and secure.
7. You must not create accounts with the Service through unauthorized means, including but not limited to, by using an automated device, script, bot, spider, crawler or scraper.
8. You are solely responsible for your conduct and any data, text, files, information, usernames, images, graphics, photos, profiles, works of authorship, applications, links and other content or materials (collectively, "**Content**") that you submit, post or display on or via the Service.
9. Violation of these Terms may, in sole discretion of SalesPartner, result in termination of your SalesPartner account. You understand and agree that SalesPartner cannot and will not be

responsible for the Content posted on the Service and you use the Service at your own risk. If you violate the letter or spirit of these Terms, or otherwise create risk or possible legal exposure for SalesPartner, we can stop providing all or part of the Service to you.

Safety

1. You must not create or submit unwanted email, comments or other forms of commercial or harassing communications (spam) to any SalesPartner users.
2. You must not defame, stalk, bully, abuse, harass, threaten, impersonate, discriminate or intimidate people or entities and you must not post private or confidential information via the Service.

General Conditions

1. We reserve the right to modify or terminate the Service or your access to the Service for any reason, without notice, at any time, and without liability to you. If we terminate your access to the Service or if you deactivate your account and all other data will no longer be accessible through your account (e.g., users will not be able to navigate to your username and view your photos), but those materials and data may persist and appear within the Service.
2. We reserve the right to force forfeiture of any username for any reason.

3. Upon termination, all rights granted to you in these Terms will immediately cease.
4. We reserve the right to refuse access to the Service to anyone for any reason at any time.
5. We may, but have no obligation to, remove, edit, block, and/or monitor Content or accounts containing Content that we determine in our sole discretion violates these Terms. SalesPartner reserves the right to remove any Content from the Service for any reason, without prior notice. 6. You agree that SalesPartner is not responsible for, and does not endorse, Content posted within the Service. SalesPartner does not have any obligation to prescreen, monitor, edit, or remove any Content. If your Content violates these Terms, you may bear legal responsibility for that Content.
7. You agree that you are responsible for all data charges you incur through use of the Service.
8. We prohibit crawling, scraping, caching or otherwise accessing any content on the Service via automated means (except as may be the result of standard search engine protocols or technologies used by a search engine with the express consent of SalesPartner).

Intellectual Property Rights

1. SalesPartner hereby grants to you a non-transferable license to use the Service. You may not distribute or make the Service available over a network where it could be used by multiple devices at the same time. You may not rent, lease, lend, sell, redistribute or sublicense the Service. You may not copy (except as expressly permitted by this license), decompile, reverse engineer, disassemble, attempt to derive the source code of, modify, or create derivative works of the Service, any updates, or any part thereof (except as and only to the extent any foregoing restriction is prohibited by applicable law or to the extent as may be permitted by the licensing terms governing use of any open sourced components included with the Service). 3. 5. The SalesPartner name and logo are trademarks of SalesPartner, and may not be copied, imitated or used, in whole or in part, without the prior written permission of SalesPartner. In addition, all page headers, custom graphics, button icons and scripts are proprietary rights of SalesPartner, and may not be copied, imitated or used, in whole or in part, without prior written permission from SalesPartner.

Third Parties

1. There may be links from the Service, or from communications you receive from the Service, to third-party (mobile) applications, websites or features. The Service may also include third-party content that we do not control, maintain or endorse. SalesPartner does not control any of these third-party web services or any of their content. No Warranty

1. The Service, including, without limitation, SalesPartner Content, is provided on an "as is", "as available" and "with all faults" basis. To the fullest extent permissible by law, neither SalesPartner nor any of its directors, employees, managers, officers, partners, affiliates or agents (collectively, the "**SalesPartner Parties**") make any representations or warranties or endorsements of any kind whatsoever, express or implied, as to: (a) the Service; (b) the SalesPartner Content; (c) user content; or (d) security associated with the transmission of information to SalesPartner or via the Service. In addition, the SalesPartner Parties hereby disclaim all warranties, express or implied, including, but not limited to, the warranties of merchantability, fitness for a particular purpose, non-infringement, title, custom, trade, quiet enjoyment, system integration and freedom from computer virus.
2. The SalesPartner Parties do not represent or warrant that the Service will be error-free or uninterrupted; that defects will be corrected; or that the Service or the server that makes the Service available is free from any harmful components, including, without limitation, viruses. The SalesPartner Parties do not make any representations or warranties that the information (including any instructions) on the Service is accurate, complete, or useful.
3. Limitation of Liability

The foregoing limitations will apply even if the above stated remedy fails of its essential purpose.

2. You agree that in the event you incur any damages, losses or injuries that arise out of acts of SalesPartner or omissions, the damages, if any, caused to you are not irreparable or sufficient to entitle you to an injunction preventing any exploitation of any website, service, property, product or other content owned or controlled by the SalesPartner Parties, and you will have no rights to enjoin or restrain the development, production, distribution, advertising, exhibition or exploitation of any website, property, product, service, or other content owned or controlled by the SalesPartner Parties.
3. SalesPartner is not responsible for the actions, content, information, or data of third parties, and you release us, our directors, officers, employees, and agents from any claims and damages, known and unknown, arising out of or in any way connected with any claim you have against any such third parties.
4. You agree that any claim you may have arising out of or related to your relationship with SalesPartner must be filed within one year after such claim arose; otherwise, your claim is permanently barred.

Indemnification

You agree to defend (at the request of SalesPartner), indemnify and hold the SalesPartner Parties harmless from and against any claims, liabilities, damages, losses, and expenses, including without limitation, reasonable attorney's fees and costs, arising out of or in any way connected with any of the following (including as a result of your direct activities on the Service or those conducted on your behalf):

- a. your Content or your access to or use of the Service;
- b. your breach or alleged breach of these Terms;

- c. your violation of any third-party right, including without limitation, any intellectual property right, publicity, confidentiality, property or privacy right;
- d. your violation of any laws, rules, regulations, codes, statutes, ordinances or orders of any governmental and quasi-governmental authorities, including, without limitation, all regulatory, administrative and legislative authorities; or
- e. any misrepresentation made by you.

You will cooperate as fully required by SalesPartner in the defense of any claim. SalesPartner reserves the right to assume the exclusive defense and control of any matter subject to indemnification by you, and you will not in any event settle any claim without the prior written consent of SalesPartner.

Paid Services

If you signup for one of our subscription services these are the terms that apply. You agree that:

1. Subscriptions are monthly or yearly and renew automatically unless you cancel before the renewal date either by cancelling inside your account, or by sending an email with 'Cancel' to contact@salespartner.co.
2. All sales are final. We do not offer full or pro-rated refunds.
3. The service will be delivered to you as is through our web interface.
4. We can not guarantee any level of interest in your product or service that we market for you.
5. You pay us for running the process as described on the website, using our web application as interface. If there are no, or unexpected results, you agree that this at your own risk.
6. We are free to execute the service in the way we prefer, without any limitation. If you are for whatever reason unhappy with this you can cancel your account.

Partial Invalidity

If, at any time, any provision of these Terms is or becomes illegal, invalid or unenforceable in any respect under any law of any jurisdiction, neither the legality, validity or enforceability of the

remaining provisions nor the legality, validity or enforceability of such provision under the law of any other jurisdiction will in any way be affected or impaired.

No Waiver

Failure of SalesPartner to insist upon or enforce strict performance of any provision of these Terms will not be construed as a waiver of any provision or right. No waiver of any of these Terms will be deemed a further or continuing waiver of such term or condition or any other term or condition.

Territorial Restrictions

1. The information provided within the Service is not intended for distribution to or use by any person or entity in any jurisdiction or country where such distribution or use would be contrary to law or regulation or which would subject SalesPartner to any registration requirement within such jurisdiction or country. We reserve the right to limit the availability of the Service or any portion of the Service, to any person, geographic area, or jurisdiction, at any time and in our sole discretion, and to limit the quantities of any content, program, product, service or other feature that SalesPartner provides.
2. No software from the Service may be downloaded, exported or re-exported: (a) into any European Union and/or U.S. embargoed countries or (b) to anyone on a sanction list maintained by the European Union and/or the U.S. Treasury Department's list of Specially Designated Nationals or the U.S. Department of Commerce Denied Person's List or Entity List. By downloading any software related to the Service, you represent and warrant that you are not located in, under the control of, or a national or resident of, any such country or on any such list.

Changes

1. We reserve the right, in our sole discretion, to change these Terms ("**Updated Terms**") from time to time.
2. Unless we make a change for legal or administrative reasons, we will provide reasonable advance notice before the Updated Terms become effective. You agree that we may notify you of the

Updated Terms by posting them on the Service, and that your use of the Service after the effective date of the Updated Terms (or engaging in such other conduct as we may reasonably specify) constitutes your agreement to the Updated Terms. Therefore, you should review these Terms and any Updated Terms before using the Service.

3. The Updated Terms will be effective as of the time of posting, or such later date as may be specified in the Updated Terms, and will apply to your use of the Service from that point forward. These Terms will govern any disputes arising before the effective date of the Updated Terms.

Governing law and jurisdiction

1. These Terms, and any non-contractual obligations arising out of or in connection with it, are governed by and construed in accordance with the laws of the Netherlands.
2. All disputes between you and SalesPartner (whether or not such dispute involves a third party) with regard to your relationship with SalesPartner, shall be submitted exclusively to the competent court of law in Den Haag, the Netherlands, without prejudice to the right of SalesPartner as plaintiff to initiate proceedings before any other court having jurisdiction. The application of the United Nations Convention on Contracts for the International Sale of Goods is expressly excluded.
